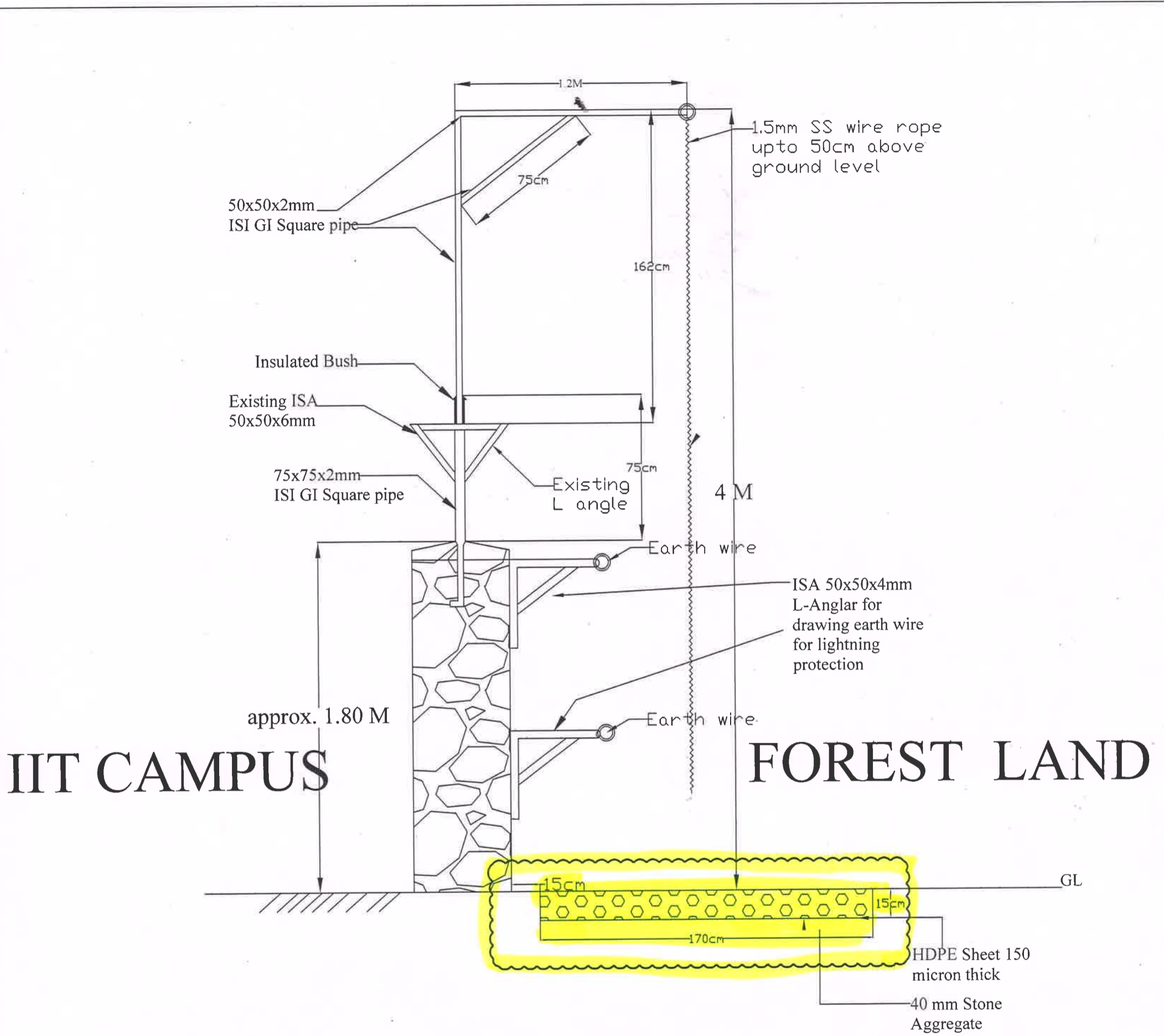


FIG: 2 CLOUDED PORTION. TYPICAL LAYOUT AT THE EXISTING COMPOUND WALL AREA

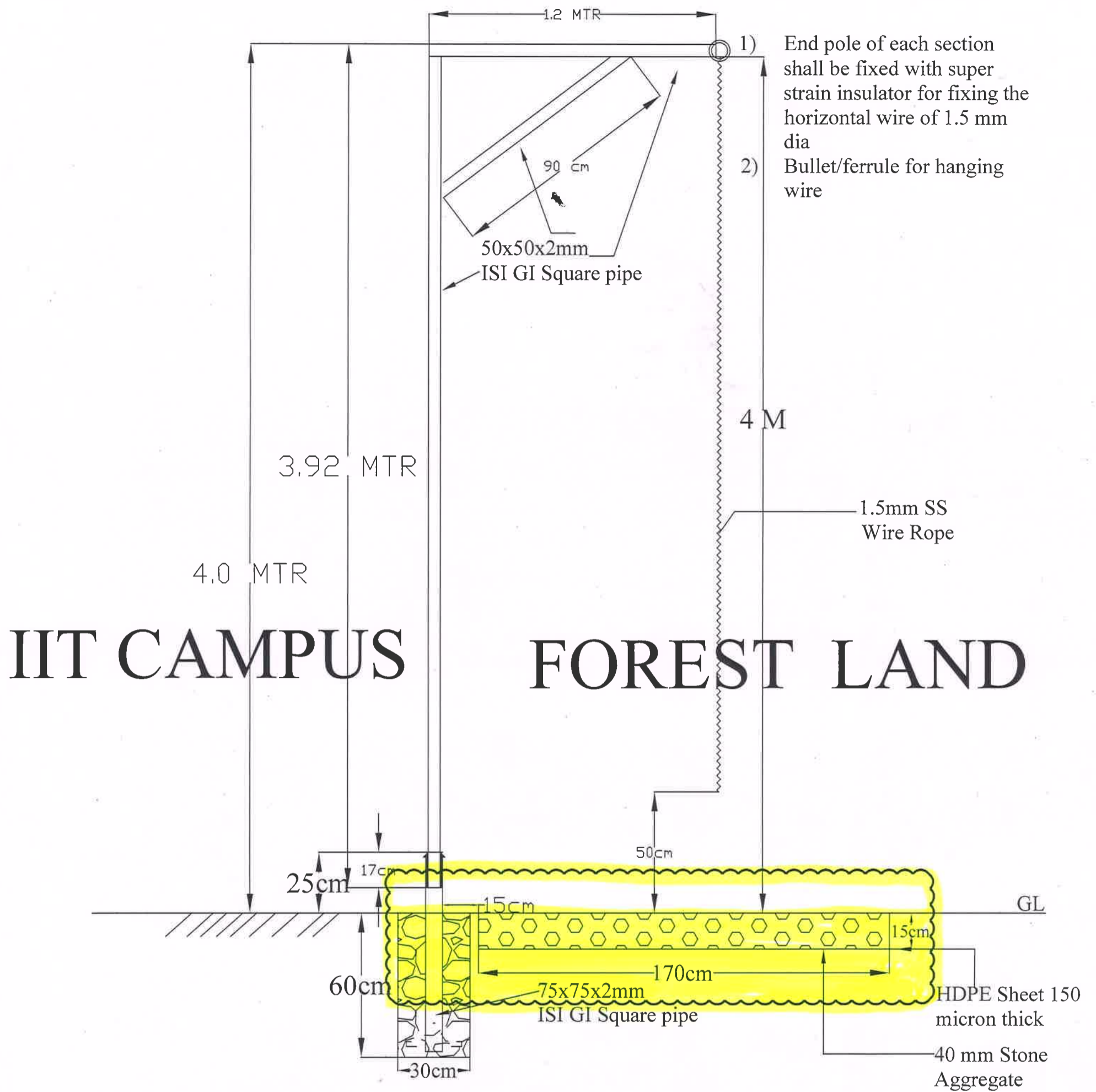


FIG 1: CLOUD PORTION.
