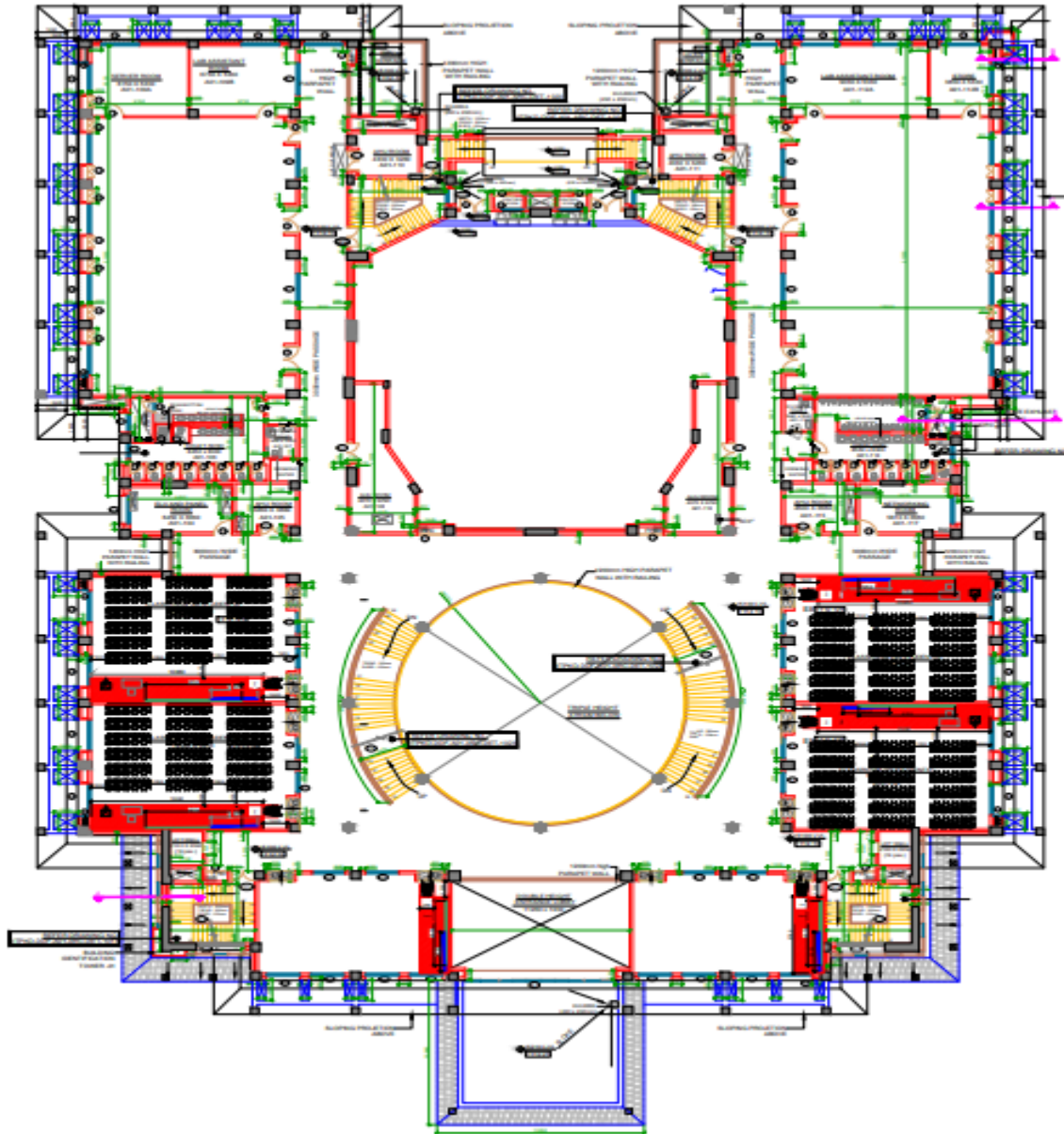

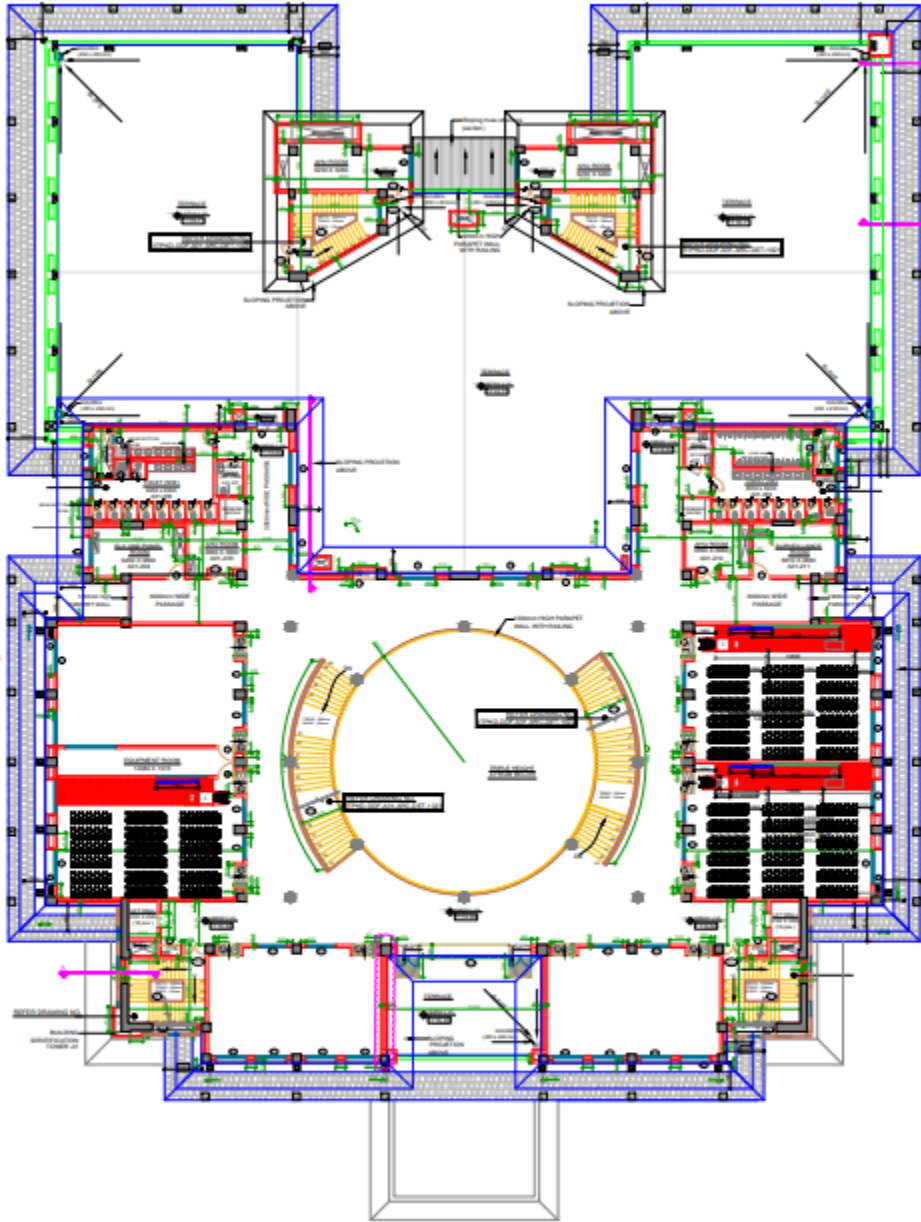

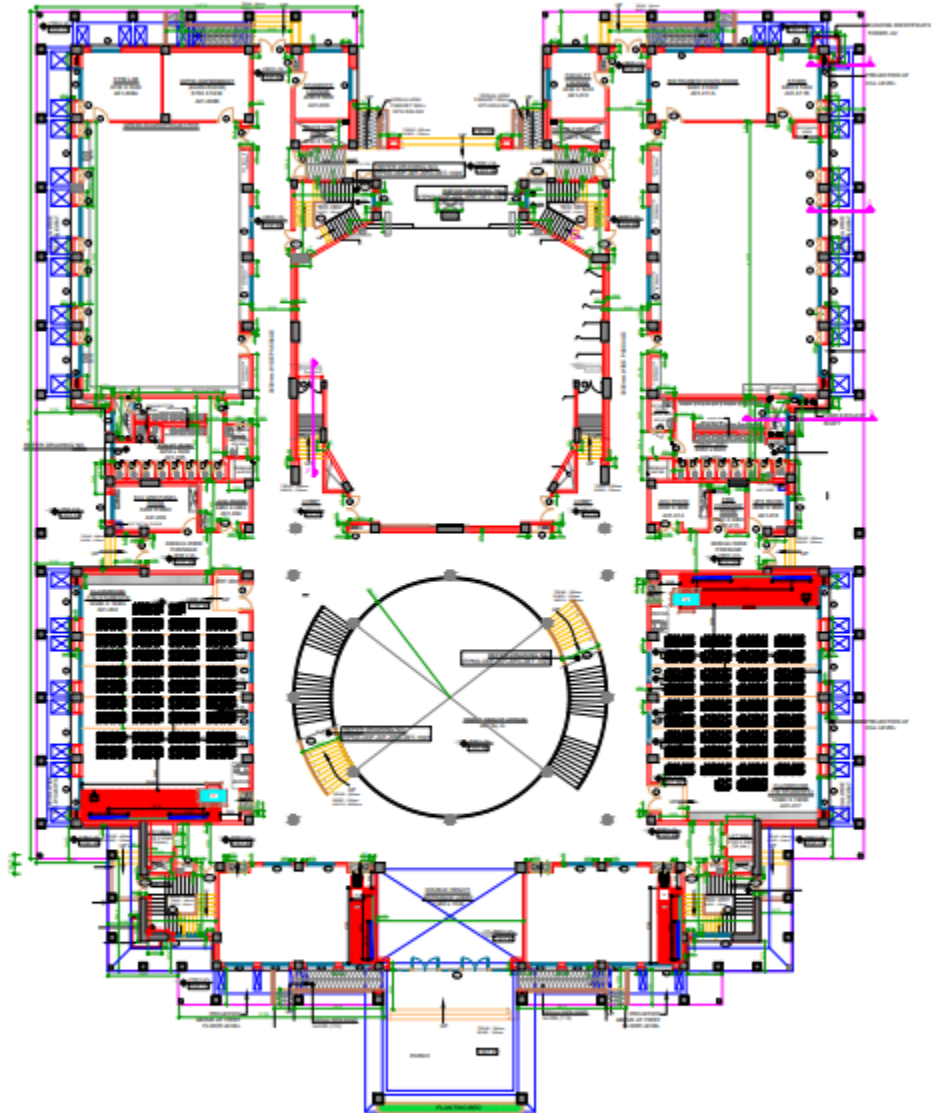

A01 FIRST FLOOR 360 FLAP CHAIR

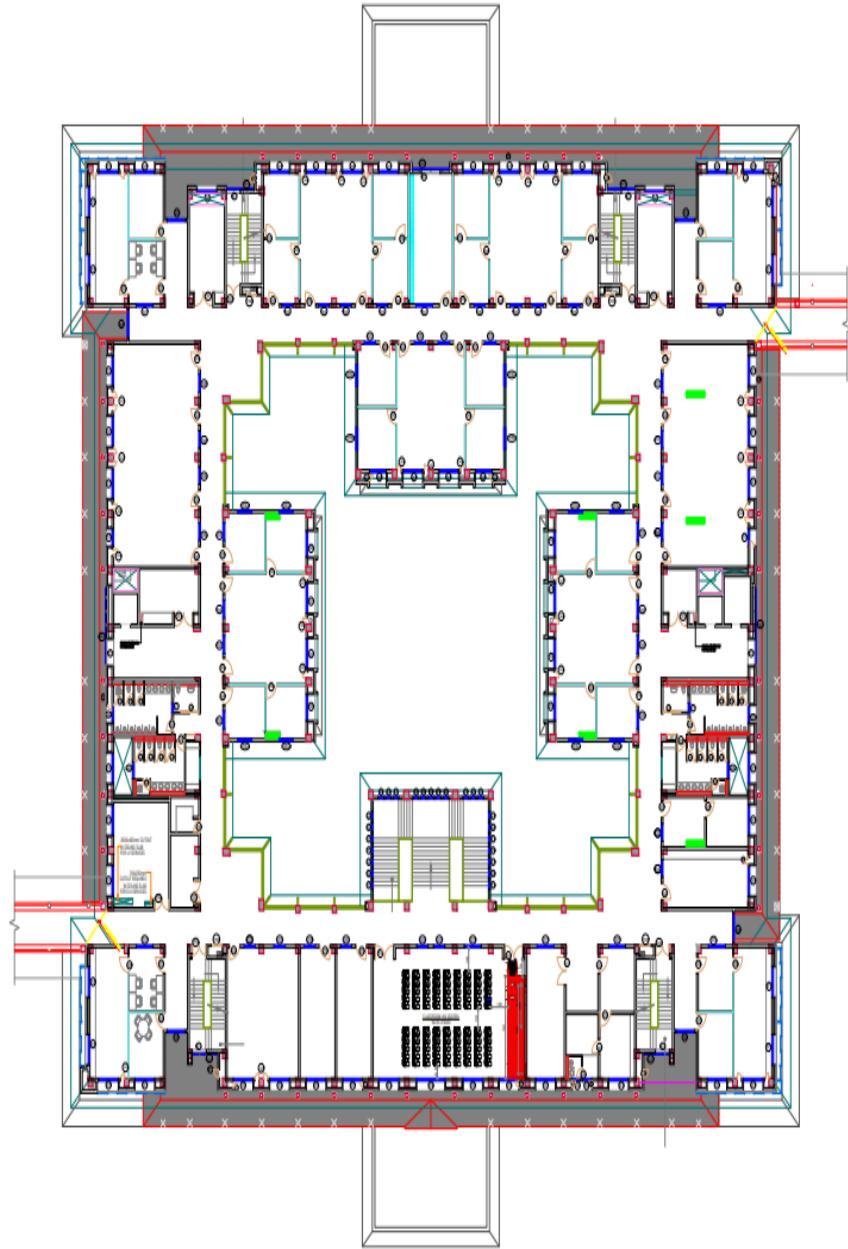


A01 SECOND FLOOR 270 FLAP CHAIR

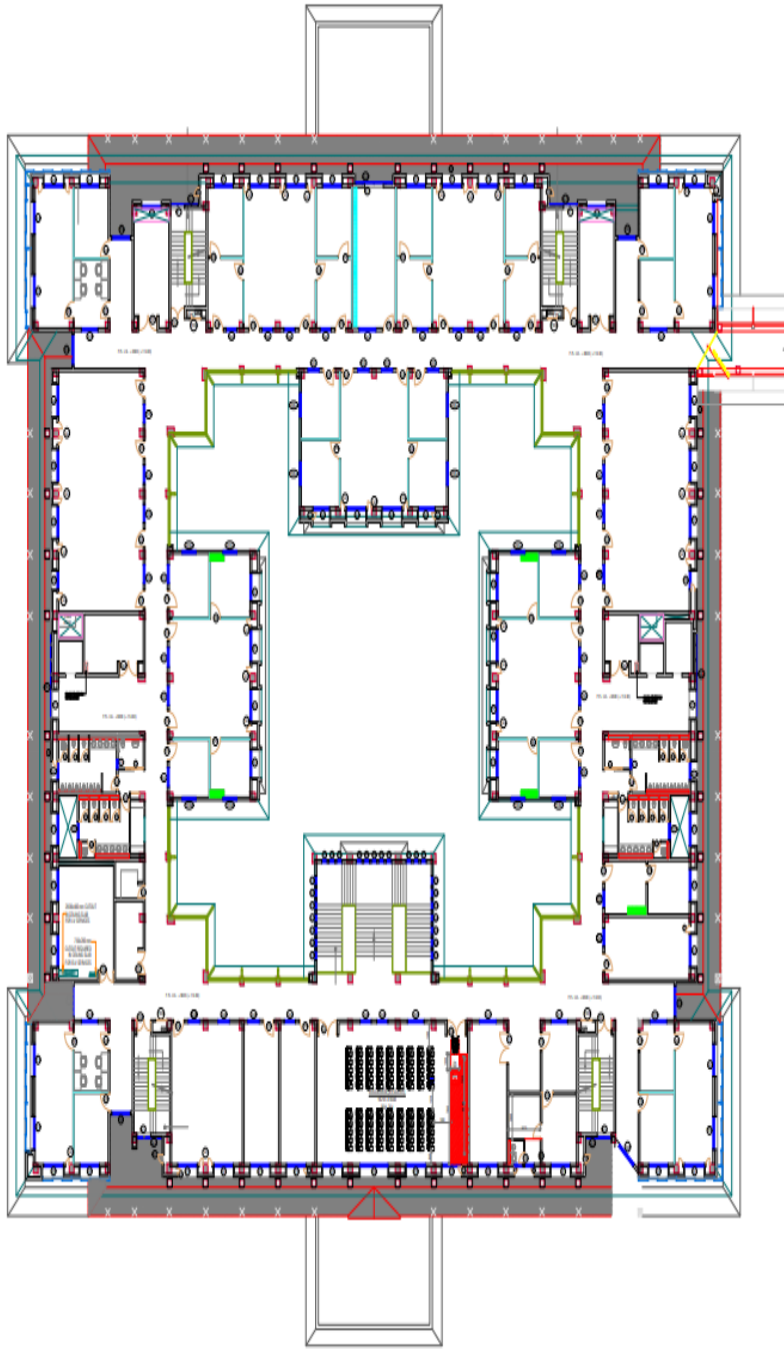
